
1. The Institution must appoint Principal and other faculty members as per AICTE Norms with pay scales as prescribed by AICTE, before making any admission..
2. The Institution must have Affiliation to a University for the above courses before making admissions. In the absence of such Affiliation, this Letter of approval shall be treated as Withdrawn. (**Order of the High Court of Madras in W.P. No. 33256 of 2002 and other Batch of Petitions**).
3. No admission shall be made by the institution, contrary to the guidelines issued by AICTE, for the academic session 2004-2005. All the admissions must necessary be made through Entrance Test.
4. All the required Laboratories/ Workshops/ Machineries/ Equipment, as per approved syllabi of the affiliating University, must be operational before making admissions.

5. The approved course(s) shall commence as per the academic calendar of the Affiliating University.
6. If this Letter of approval is received by you after the closing date of State / National Level Central Counseling for Admissions in the concerned State / Union Territory, this Letter of approval shall not be valid for making any admission, and shall be treated as withdrawn.
7. No excess admission shall be made by the Institution during any academic year.
8. The approval is valid only for the academic year 2004-2005. This Approval Letter will not be valid for making any admission for the subsequent years.
9. In exercise of power conferred under 10(p) of the AICTE Act, AICTE, may inspect the Institution any time it may deem fit to verify the progress/ compliance or for any other purpose.
10. Any other condition(s) as may be specified by AICTE from time to time.
11. Consequent to the Supreme Court Judgment, the Model Constitution of Governing Body as notified by AICTE in its Approval Regulations 1994, stands overruled. It has been decided that while AICTE will not insist on any nomination in the Governing Body of Private unaided Institutions, the Affiliating University/ State Government affiliation, such as, prescription of qualification of governing body members, in order to ensure academic excellence. It shall be desirable for the private unaided institutions to induct at least 50% of members of the Governing Body drawn from renowned academia, academic administrators, subject field experts and professionals from industry in order to seek their innovative ideas for continuous improvement in the delivery of teaching learning process, matching best practice elsewhere and achieve excellence.

**In the event of infringement/ contravention or non-compliance of the above Conditions and/or the provision of AICTE Act & Regulations/ Guidelines/ Norms & Standards as prescribed by AICTE, further actions leading to 'Reduced Intake' or "No Admission or Withdrawal of Approval, may be taken by AICTE and the liability arising out of such actions will be solely that of the Management/ Trust/ Society and/ or the Institution.**

Please note that the Council would verify the status in respect of recruitment of faculty and rectification of other deficiencies through surprise inspection without any prior intimation. The institution shall be liable for strict action including action under the relevant provisions of Indian Penal Code in case false information is furnished to the Council.

The Council has decided to undertake inspections without any prior notice before extending approval for the year 2006-07 anytime after August, 2005. A compliance report in respect of deficiencies listed in Annexure-A must be sent to the Council with a copy to the concerned Regional office before 31<sup>st</sup> August, 2005 in the absence whereof extension of approval for year 2006-07 may not be considered.

Sir/Madam,

As you are aware, All India Council for Technical Education has been mandated under the AICTE Act, 1987 to ensure maintenance of norms and standards with regard to technical education in the country. In exercise of this mandate, the Council insists on fulfillment of the minimum requirements prescribed for imparting technical education by the institution so that quality of courses is not compromised and stakeholders are satisfied. The Council also undertakes an annual inspection of the institutions and conveys deficiencies to them for rectification.

Such institutions suffer from critical deficiencies of faculty in proper cadre ratio's qualification, experience and other requirements. Feed back of students with regard to quality of education imparted by such institutions has evoked grave concern. The Expert Committees, following holistic appraisal during inspections, have also pointed out severe shortcomings in key areas.

The institution was allowed to be established in the year 2004-05. The Inspection and Appraisal have revealed that adequate steps to provide the requisite infrastructure necessary for imparting quality technical education have not been taken. The institution has been found to be suffering from several deficiencies which are listed in Annexure-A for your perusal of which faculty shortage is the most critical.

The deficiencies particularly faculty shortage have evoked grave concern and rendered the institution liable for strict punitive action including being placed in no admission/reduced intake category. However the Council has decided that yet another last opportunity may be given to the institution to improve the situation as you are still a fledgling institution.

It has thus been decided to extend approval in respect of the institution for the year 2005-06 as indicated below, subject to rectification of deficiencies by end of August, 2005. The Council shall monitor progress in this regard carefully and strictly and shall put your institution in no admission/reduced intake category for the year 2006-07 without any further opportunity in the event of your failure to comply with the aforementioned stipulations. The approved course(s) along with recommended intake for the year 2005-06 in respect of Institute of Management Studies, A-8B, Sector - 62, Institutional Area, Noida is as under:-
